### CUSTOMER'S RESPONSIBILITIES BEFORE WINTERIZING

- A. PLEASE KEEP POOL PUMP OPERATING UNTIL IT IS TIME FOR US TO WINTERIZE YOUR POOL.
- B. **IT IS REQUIRED THAT YOU BRING ONE (1) PINT OF WATER INTO OUR STORE TO BE TESTED BEFORE WE WINTERIZE YOUR POOL. MAKING SURE YOUR POOL WATER IS BALANCED BEFORE WINTERIZING WILL PROLONG THE LIFE OF YOUR POOL INTERIOR AND REDUCE COSTLY SPRING CLEAN UP.**  
**\*TEST SHOULD BE PERFORMED ONE WEEK BEFORE CLOSING \***
- C. **SOFTSWIM® CUSTOMERS MUST COME TO THE LAB TO GET ANALYSIS ON (B) AND (C) LEVELS MEIER'S TO ADD (A) ONLY.**
- D. CUSTOMER TO VACUUM POOL THOROUGHLY PRIOR TO MEIER'S CLOSING.
- E. **BEFORE YOUR POOL IS CLOSED USE KLEEN IT® FILTER CLEANER OR SOFTSWIM® AT LEAST 48 HOURS BEFORE TO RID YOUR FILTER OF SCALE BUILDUP.**
- F. WHEN POSSIBLE CUSTOMER TO LOWER WATER LEVEL JUST BELOW RETURNS PRIOR TO MEIER'S CLOSING.
- G. AFTER OCT. 31st., THERE WILL BE AN EXTRA \$200.00 CHARGE. ANY POOL CLOSED AFTER OCT. 31st., THERE WILL BE NO GUARANTEE.

### MEIER'S WINTERIZING RESPONSIBILITIES

- 1. MEIER'S TO SKIM INCIDENTAL AMOUNTS OF LEAVES FROM SURFACE OF POOL WATER FOR COVERED POOLS ONLY.
- 2. BACKWASH FILTER AND DRAIN ALL NECESSARY EQUIPMENT. (FILTER SYSTEM, HEATER, CHLORINATOR).
- 3. WINTERIZING SKIMMERS, HEATER AND PUMP, BLOW OUT UNDERGROUND PLUMBING LINES. (PLUGS AND GIZZMOS WHEN NEEDED WILL BE AN ADDITIONAL CHARGE).
- 4. ADD NON-TOXIC ANTI-FREEZE TO FREEZABLE ENTRAPMENTS.
- 5. REMOVE POOL EQUIPMENT FOR CUSTOMER TO STORE. (I.E. LADDERS, GRAB RAILS, VOLLEYBALL, BASKETBALL, (LEFT ASSEMBLED) (DIVING BOARDS WILL NOT BE REMOVED).
- 6. COVER POOL WITH OWNER'S COVER. (WASH SOLAR BLANKET WITH STOW AWAY®). BLANKETS ON REELS WILL BE CLEANED AND LEFT ON REEL. **SOLAR BLANKETS THAT ARE DETERIORATED WILL NOT BE CLEANED.**
- 7. INGROUND SPA'S MUST BE WINTERIZED AT THE SAME TIME AS THE SWIMMING POOL OR WARRANTY WILL BE VOID.
- 8. MAIN DRAIN RED HANDLE & PLUGS REMOVED AND STORED INSIDE HEATER.
- 9. WINTERIZING SERVICE INCLUDES ALL LABOR AND THE FOLLOWING WINTERIZING CHEMICALS.
  - 1 QUART WINTER ALGICIDE PER EVERY 25,000 GALLONS. (NOT INCLUDED W/BLOW LINES ONLY)
  - NON-TOXIC ANTI-FREEZE AS NEEDED.
  - 1 LB. WINTER SHOCK PER EVERY 10,000 GALLONS. (CHLORINE POOLS ONLY NOT INCLUDED W/BLOW LINES ONLY)
- 10. ANY OTHER WORK PERFORMED DURING POOL CLOSING WILL BE AT AN ADDITIONAL CHARGE.
- 11. COMMERCIAL POOLS NEEDING ANY WORK INCLUDING CLOSING WILL BE PRICED ON AN INDIVIDUAL BASIS.

### CUSTOMER'S RESPONSIBILITIES AFTER CLOSING TO GUARANTEE WINTERIZING.

- A. CUSTOMER TO RAISE WATER INTO THE SKIMMERS FOR ALL COVERED POOLS.
- B. **NATURE 2 CARTRIDGE MUST BE REPLACED IN THE SPRING BY CUSTOMER**

**TERMS OF CONTRACT**

MEIER'S agrees to supply necessary materials, and perform all labor to winterize pool (as per contract). Customer does hereby agree to pay MEIER'S any additional material or labor costs, not included in this contract, but done at customer's request. Customer is responsible to keep pool filtration system operating until MEIER'S winterizes pool. IF FREEZING OR DAMAGE OCCURS FROM CUSTOMER NOT HAVING FILTRATION SYSTEM OPERATING, MEIER'S IS NOT LIABLE.

**MEIER'S ASSUMES NO RESPONSIBILITY FOR DAMAGE TO OR SHIFTING OF WINTER COVER CAUSED BY WIND, RAIN, SNOW, ICE, WATER LEVELS, LINERS FLOATING OR OTHER UNFORESEEN CONDITIONS.**

IF THE AMOUNTS TO BE PAID PURSUANT TO THE TERMS OF THIS CONTRACT ARE NOT PAID WITHIN 10 DAYS AFTER DUE DATE AS HEREIN BEFORE SPECIFIED FOR EACH SUCH PAYMENT. A DELINQUENCY CHARGE ON EACH SUCH INSTALLMENT IN DEFAULT OF 1-1/2% OF THE INSTALLMENT PER MONTH SHALL BE CHARGED AND THE CUSTOMER HEREBY AGREES TO PAY SUCH DELINQUENCY CHARGE IN ADDITION TO THE CONTRACT PRICE HEREIN SPECIFIED, IN ADDITION, THE CUSTOMER IS OBLIGATED TO PAY COSTS AND DISBURSEMENTS, INCLUDING REASONABLE ATTORNEY'S FEES, INCURRED BY MEIER'S IN LEGAL PROCEEDINGS TO COLLECT THE SUMS DUE PURSUANT TO THIS CONTRACT AFTER DEFAULT.

To secure payment hereof, the undersigned, jointly and severally, hereby irrevocably authorize any attorney of the Court of Record to appear for them, or either or any of them, in such Court, in term time or vacation, at any time after default in payment hereof, and confess judgement without process against them, or any one of them, in favor of MEIER'S, for such sum as may appear to be unpaid and owing therein together with any delinquency charges, interest, costs and reasonable attorney's fees, and to waive and release all errors which may intervene in such proceeding and consent to immediate execution upon such judgement, hereby ratifying and confirming all that said attorney may do by virtue hereof. This contract has been executed and delivered at Fox Lake, Illinois, and shall be governed by the laws of the State of Illinois. If any provision of this contract shall be prohibited or invalid under applicable law, the remaining provisions shall not be invalidated. If this contract is signed by more than one person, their obligations hereunder shall be joint and several.

When this proposal is accepted by the Customer, this proposal becomes a BINDING CONTRACT between both the Customer or MEIER'S OUTDOOR WORLD of 155 S. Sayton Road, Unit B, Fox Lake, Illinois 60020.
